MEMBERSHIP INFORMATION

Within the Iona Community's 'constituency' there are four different categories of membership:

Friends contribute to the work and concerns of the Community by making an annual donation without committing themselves to keeping any of the Community's Rules. They receive the Community's Annual Report, Wild Goose Publications catalogue, the Iona/Camas Programme and, the Community's magazine, *Coracle*.

Associate Members are in agreement with the Community's work and concerns and commit themselves to participating in the life of the Community by undertaking the same Daily Prayer and Bible-reading discipline as Members; make an annual donation to the work of the Community, and having the opportunity to renew their commitment on St. Columba's Day, June 9.

There is an option of keeping an economic discipline and contributing to a common fund to support agreed projects and having the opportunity to meet regularly with other Associates through regional Associates' Groups. Their interests and concerns within the life of the Community are promoted through the Associates Advisory Group, comprising representatives from each area and reporting regularly to the Iona Community's Council. In addition to the *Coracle* and other information as listed above for Friends, each year Associates receive a copy of the Associates' Prayer List and the Members' Prayer Lectionary

Youth Associates are young adults (18-30) who are keen to explore concerns of spirituality and social justice, and strengthen and develop their links with the Community. They receive the same information as Associate Members as well as specific information from the youth department. A representative serves on each of the Community's operating committees to put forward the views of young people.

Full Members share a common discipline of: Daily Prayer and reading the Bible; mutual accountability for the use of time and money; meeting together; and action for justice and peace. Members require to have been Associates for around two years, and to complete a Two Year Joining Programme.
